Deck Defense™ High Performance Roof Underlayment Limited Warranty



Limited Warranty on Deck Defense™ High Performance Roof Underlayment

Limitations on the transferability of this warranty are set forth herein.

Introduction

Thank you for your recent purchase of Deck Defense™ High Performance Roof Underlayment (“Deck Defense Underlayment”) from Owens Corning Roofing & Asphalt, LLC (“Owens Corning”). We have attempted to write this warranty in clear, plain-English terms, including the limitations and restrictions, so you will fully understand the warranty we are making to you. Who Is Covered

If you live in the United States or Canada and you are the original consumer purchaser (i.e., the homeowner, not the installer or contractor) of Deck Defense Underlayment, you are entitled to the benefits of this warranty.

Transferability of This Warranty

This warranty is personal to you and may not be transferred to any subsequent purchaser of your home.

How Long Are You Covered

The length of the warranty period for Deck Defense Underlayment shall be the warranty period for the original layer of shingles applied to your roof, up to a maximum warranty period of thirty (30) years following installation. Reference your shingle warranty to determine the applicable warranty period for Deck Defense Underlayment.

What Is Covered

We warrant that this roofing product will be free from any manufacturing defects that materially affect its performance on your roof.

What Is Not Covered

Damage to the product due to any cause not expressly covered herein. After our Deck Defense Underlayment leaves the manufacturing facility, it is subjected to conditions and handling beyond our control that could affect its performance. This warranty does not cover any problems with non-defective Deck Defense Underlayment caused by conditions or handling beyond our control. Some examples of conditions not covered by this warranty include:

1. Acts of God, such as hail and strong storms;
2. Damage to or failure of Deck Defense Underlayment as a result of damage to or the failure of the underlying roofing structure;
3. Foot traffic on your roof or damage caused by object(s) (i.e., tree branches) falling on your roof;
4. Exposure to the elements (except for damages resulting from UV degradation if left exposed for less than 180 days);
5. Leaks caused by fasteners;
6. Inadequate roof drainage or attic ventilation. If you have any questions about appropriate drainage or ventilation requirements, please contact us at 1-800-ROOFING;
7. Settlement of the structure of your property or buckling or cracking of the deck over which your Deck Defense Underlayment is installed;

8. Damage to the Deck Defense Underlayment caused by alterations made after completion of application, including structural changes, equipment installation, painting, or the application of cleaning solutions, coatings, or other modifications;
9. Improper storage, handling or other conditions beyond our control;
10. Damages caused by, or the cost to repair, any non-Owens Corning™ Roofing products;
11. Improperly designed or installed gutter or downspout systems;
12. Improper or faulty installation of Deck Defense Underlayment (installation must be in accordance with the then current written installation instructions);
13. Application of Deck Defense Underlayment on roof slopes less than a 2:12 pitch;
14. Re-roof over existing underlayment; and
15. Any costs that you incur which are not authorized in advance by Owens Corning.

What Is Your Remedy

If at any time up to the maximum warranty period of thirty (30) years, based on the field shingle installed, the Deck Defense Underlayment does not retain its ability to shed water due to a manufacturing defect, Owens Corning will contribute to the cost of either repairing or replacing your Deck Defense Underlayment at our sole option and as it's our sole obligation to you, subject to the following limitations:

During the first ten (10) years following installation, our liability under this warranty shall be limited, at our sole discretion, to repairing or replacement of your Deck Defense Underlayment or a refund equal to the cost of replacement of the Deck Defense Underlayment excluding cost of labor.

During years eleven (11) through up to thirty (30) following installation, our liability shall be limited, at our sole discretion, to repairing or replacement of the Deck Defense Underlayment or a refund equal to the cost of replacement of the Deck Defense Underlayment, excluding the cost of labor, subject to proration as calculated by the formula set forth below.

The proration formula takes into account the number of months of use you have enjoyed through the date of your claim and reduces a refund for cost of replacement accordingly. That is, we will prorate the amount of your payment through the date of your claim. The Deck Defense Underlayment has a maximum warranty period of 30 years (360 months), based on the field shingle installed. Thus, if you make a claim in the last month of the 11th year of the warranty (i.e., the 132nd month), and the warranty on the first shingle you installed was 30 years, the warranty refund amount would equal 228/360ths of the cost of replacement of Deck Defense Underlayment, excluding the cost of labor.

Claims Process

To make a claim under this warranty, you must notify us within thirty (30) days of discovering the problem. Visit us at www.roofing.owenscorning.com/homeowner/warranty/claimform.aspx or call 1-800-ROOFING. If selecting the Internet option, you will be required to complete the claim form in its entirety and provide a valid e-mail address. Once we receive your electronic submission, we will reply via e-mail with instructions on how to proceed in the claim

process. If selecting the toll-free phone option, you may use the automated prompts (24 hours a day/7 days a week) or speak with a representative (M-F 8:00AM-8:00PM EST) to open a claim. To fully evaluate your claim we require that, at your expense, you provide pictures, underlayment samples for advanced testing, and related documentation including proof of residence. Details regarding these requirements will be included in the packet sent to you once your claim is opened. Limitations

ANY IMPLIED WARRANTY, INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, IS LIMITED IN DURATION TO THE EXPRESS WARRANTY PROVIDED HEREIN.

YOUR REMEDY FOR DEFECTIVE DECK DEFENSE UNDERLAYMENT IS FULLY DESCRIBED IN THE SECTION ENTITLED “WHAT IS YOUR REMEDY.” YOU ARE NOT ENTITLED TO ANYTHING MORE THAN WHAT IS DESCRIBED IN THAT SECTION. OWENS CORNING IS NOT RESPONSIBLE FOR ANY CONSEQUENTIAL OR INCIDENTAL DAMAGES, INCLUDING BUT NOT LIMITED TO, ECONOMIC LOSS, LOSS OF PROFITS OR REVENUE OR COSTS ARISING FROM THE LOSS OF USE OF PRODUCTS OR COST OF SUBSTITUTE PRODUCTS. OWENS CORNING SHALL NOT BE RESPONSIBLE FOR ANY CONSEQUENTIAL OR INCIDENTAL DAMAGES, INCLUDING DAMAGE TO YOUR HOME OR BUSINESS OR TO YOUR HOME OR BUSINESS' CONTENTS.

Some states do not allow limitations on how long an implied warranty lasts and/or do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you. This warranty gives you specific legal rights, and you may have other rights which vary from state to state.
